CIRCULAR

Whereas in compliance of the Judgment Pronounced on 25.05.2007 by the Division Bench of Hon'ble Rajasthan High Court in D.B.C.W.P No. 20/1993 Satveer Singh V/s RHB, D.B Special Appeal (Civil) No. 64/1993 R.K Bhakar V/s K.K Dixit and Ors, D.B Special Appeal (Civil) No. 67/1993 Chandra Mohan Saharan & Ors. V/s K.K Dixit and Ors, D.B Civil Special Appeal (W) No. 528/1993 R.K Bhakar V/s K.K Dixit and Ors,, D.B Civil Writ Petition No. 7063/1993 Ranjeet Singh Godara & Ors V/s RHB & Ors, D.B Civil Special Appeal (W) No. 497/1994 Faheem Ullah Khan V/s RHB and D.B Civil Special Appeal (W) No. 689/1996 Ramesh Chand Jain & Ors. V/s RHB, final seniority list of Project Engineer (Jr.) was published vides Board Order No. - P1 (1)KARMIK/SENIORITY/P.E (JR) /07/1547 Dated 27.08.2007.

After publication of the final seniority list, several Project Engineer (Jr.) appointed in the year 1992-93 are not satisfied as per placement of their names in seniority list and continuously requesting to the Board Authority to correct the seniority list in order of merit as assigned to them by the Junior Selection Committee. The names of Project Engineers (Jr.) appointed in the year 1992-93 appear at S. No. - 197 to 233 in the said seniority list.

Against the said seniority list published on 27.08.2007 showing the position as on 01.04.2007, the several representation have been received / are being received from the aggrieved P.E (Jr.) and their representation have been examined in view of the Judgment Pronounced on 25.05.2007, the Hon'ble Rajasthan High Court and as per provision of Recruitment & Promotion Regulation 1976. As such a necessity has arisen to re-draw the seniority list of P.E (Jr.) Degree & Diploma holders whose names appears at S. No. - 197 to 233. As such the seniority of P.E (Jr.) published vide Order No. - P1 (1)KARMIK/SENIORITY/P.E (JR) /07/1547 dated 27.08.2007 in respect of S. No. - 197 to 233 are hereby withdrawn with immediate effect and fresh provisional seniority list of Project Engineer (Jr.) from S. No. - 197 to 233 showing the position as on 01.04.2007 is hereby published and the same is circulated to all concerned inviting

objection, if any, within 7 Days from the date of publication of provisional seniority list, where after no representation will be entertained after the schedule date and final seniority list will be published

The following criteria have been adopted in publishing this seniority List.

1. - As per Judgment of Divisional Bench of the Hon'ble Rajasthan High Court Pronounced on dated 25.05.2007, the common seniority of Project Engineer (Jr.) Degree & Diploma holders are to be maintained.
2. - S. No. - 1 to 13 contains the names of those P.E (Jr.) who were interviewed on 26,27 & 28.11.1991 and whose names were recommended by the Junior Selection Committee in the main list for appointment as Project Engineer (Jr.). The inter-se-seniority amongst Degree & Diploma holders have been assigned as per merit (% of aggregate marks) recommended by the Junior Selection Committee.
3. - S. No. - 14 to 24 and 25 to 26 contains the names of these P.E (Jr.) who were interviewed on 26,27 & 28.11.1991 & and their names were recommended by the Junior Selection Committee in the reserve / waiting list for appointment as Project Engineer (Jr.) subject to availability of vacant post. The inter-se-seniority amongst Degree & Diploma holders have been assigned as per merit (% of aggregate marks) recommended by the Junior Selection Committee.
4. - S. No. - 27 to 35 contain the names (Existing Board Employees) of those P.E (Jr.) who were given appointment against the post reserve for quota of **Ex-military personnel's**. It is also re-iterated that in the appointment order, it has been clearly mentioned that their inter-se-seniority will remain as per appointment order.
5. - S. No. - 36 to 37 contain the names (Existing Board Employees) of those Electrical P.E (Jr.) who were given appointment against the post reserve for quota of **Ex-military personnel's**. It is also re-iterated that in the appointment order, it has clearly been mentioned that their inter-se-seniority will remain as per appointment order.
