'APNI SHOP-APNA VYAVSAY' SCHEME TO BE LAUNCHED TO PROMOTE SELF-EMPLOYMENT

Commissioner Pawan Arora said that amidst corona, there has been reduction in jobs in private sector, and salary of employees has also been reduced. Thus, youth are inclined to start their own business. For whic, RHB will launch 'Apne Shop-Apna Business' scheme on October 2. Under it, about 1,544 commercial plots or shops built up to 27 sqm size will be sold through e-bid submission & 137 shops or plots, more than 27 sqm in size will be disposed off by e-auction.

Nagar Sector 17 of Jaipur. "This will be a self-funded scheme wherein 192 multi-storey flats will be built. The built-up area of a flat will be 3,211 sq ft. The flat will be 3 BHK, with a drawing room and a servant room and the estimated cost of a flat will be around Rs 91.58 lakh," Arora said.

He said that it will be mandatory for the applicant to furnish the certificate issued by a competent officer and salary slip to prove the said individual was in the All India Service. "In the application form, heir nomination can be made only from immediate relations. Any flat allotted by lottery will not be changed. but if any two or more allottees want to exchange the allotted flat

with mutual consent, then the consent can be given," he said.

"The club house to be developed under the scheme will be maintained and operated by the AIS Group Housing Co-operative Society, but cleaning and maintenance of the residential complex will be done by the Resident Welfare Society," Arora said.

Work order for construction of main educational block of coaching hub will be given by the end of this month.
