### SUB :- GRANT OF DEARNESS ALLOWANCE TO THE BOARD EMPLOYEES & GOVT. EMPLOYEES WHO ARE ON DEPUTATION.

The Board is pleased to order that the existing rates of Dearness Allowance (D.A.) payable to the Board Employees (Regular & Work Charged) under Finance Department Order No. F.6(1)FD/Rules/2008Pt. Jaipur & F.14(14)FD/Rules/2006 dated 31-10-2022 shall be revised with effect from respect of those employees whose pay had not been revised for different reasons or who has exercised an option to continue in the pay scales as contained in the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998 as under :-

5. Out of 61% Dearness Allowance sanctioned vide Finance Department order no. F.7(1)FD(Rules)/98 dated 28-02-2004 (Regular Employees) and No. F.1(4)FD/Exp.III/94 dated 11-05-2004 (Work Charged Employees) 50% Dearness Allowance has been treated as Dearness Pay w.e.f. 01-07-2004 as per Finance Department order no. F.6(3)FD(Rules)/2004 dated 24-05-2004 (Regular Employees) and No. F.1(14)FD/Exp.III/94 dated 28-06-2004 (Work Charged Employees).
6. Dearness Allowance @ 381 % as indicated in item (2) of Finance Department Order No. F6(1)FD/Rules/2008 Pt. & F.14(14)FD/Rules/2006 dated 25-04-2022, payable on the total of Basic Pay Plus Dearness Pay is revised to 396% w.e.f. 01-07-2022 as under:-

With effect from	Existing Rate	Increase in Existing Rate	Revised Rate
01-07-2022	381%	15%	396%

7. The term "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay, as defined in Rule 7(24) (i) of Rajasthan Service Rules drawn in the Revised Pay Scales prescribed under the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998 and shall not include any other type (s) of pay like special pay, personal pay etc.
  - (e) The arrear w.e.f. 01-07-2022 to 30-09-2022 shall be paid in cash to the Board Employees (Regular including Work Charged).
  - (f) The employees who are working on deputation from state government the period from 01-07-2022 to 30-09-2022 shall be credited to the General Provident Fund Account of the respective employees and cash payment shall be admissible from 01-10-2022 i.e. salary for the month of October, 2022 payable on 01-11-2022 in respect of Govt. Employees who are on deputation in the Board.
8. The payment on account of Dearness Allowance involving a fraction of a rupee may be rounded off to the nearest rupee.
