**SUB :- GRANT OF DEARNESS ALLOWANCE TO THE BOARD EMPLOYEES REGULAR INCLUDING WORK CHARGED & GOVT. EMPLOYEES WHO ARE ON DEPUATION.**

The Board is pleased to order that the existing rates of Dearness Allowance (D.A.) payable to the Board Employees drawing pay in Rajasthan Civil Services (Revised Pay) Rules, 2008 under Finance Department Order No. F.6(1)FD(Rules)/2008 Jaipur Dated 12-05-2023 Shall be revised with effect from 01-01-2023 as follow :-

With effect from	Existing Rate	Increase in Existing Rate	Revised Rate
01-01-2023	212%	09%	221%

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. pay drawn in the pay band and grade pay drawn and shall not include any other type (s) of like Special Pay of Personal Pay etc.

The payment of account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The arrears for the period from 01-01-2023 to 31-03-2023 shall be credited to the General Provident Fund Account of the respective employees and cash payment shall admissible from 01-04-2023 i.e. salary for the month of April, 2023 payable on 01-05-2023 in respect of Govt. Employees who are on deputation in the Board.

DA at revised rates as above would also be admissible to work charged employees as work-charged employees have been taken into their respective departmental service rules vide order no. F.14(4)FD/(Rules)/2006 Part Jaipur, dated 13.03.2023

The arrear w.e.f. 01-01-2023 shall be paid in cash to the Board Employees (Regular including Work Charged).
