SUB:- GRANT OF DEARNESS ALLOWANCE TO THE BOARD EMPLOYEES & GOVT. EMPLOYEES WHO ARE ON DEPUATION.

The Board is pleased to order that the existing rates of Dearness Allowance (D.A.) payable to the Board Employees (Regular & Work Charged) under Finance Department Order No. F.6(1)FD/Rules/2008Pt. Jaipur & F.14(14)FD/Rules/2006 dated 31-10-2022 shall be revised with effect from respect of those employees whose pay had not been revised for different reasons or who has exercised an option to continue in the pay scales as contained in the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998 as under:-

- 1. Out of 61% Dearness Allowance sanctioned vide Finance Department order no. F.7(1)FD(Rules)/98 dated 28-02-2004 50% Dearness Allowance has been treated as Dearness Pay w.e.f. 01-07-2004 as per Finance Department order no. F.6(3)FD(Rules)/2004 dated 24-05-2004
- 2. Dearness Aliowance @ 396 % as indicated in item (2) of Finance Department Order No. F6(1)FD/Rules/2008 Pt. dated 31-10-2022, payable on the total of Basic Pay Plus Dearness Pay is revised to 412 % w.e.f. 01-01-2023 as under:-

With effect from 01-01-2023

Existing Rate 396%

Increase in Existing Rate

Revised Rate 412%

- 3. The term "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay, as defined in Rule 7(24) (i) of Rajasthan Service Rules drawn in the Revised Pay Scales prescribed under the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998 and shall not include any other type (s) of pay like special pay, personal pay etc.
 - (i) The arrear w.e.f. 01-01-2023 to 31-03-2023 shall be paid in cash to the Board Employees (Regular including Work Charged).
 - (ii) The employees who are working on deputation from state government the period from 01-01-2023 to 31-03-2023 shall be credited to the General Provident Fund Account of the respective employees and cash payment shall admissible from 01-04-2023 i.e. salary for the month of April, 2023 payable on 01-05-2023 in respect of Govt. Employees who are on deputation in the Board.
- 4. DA at revised rates as above would also be admissible to work charged employees as work-charged employees have been taken into their respective departmental service rules vide order no.F.14(4)FD/(Rules)/2006 Part Jaipur, dated 13.03.2023
- 5. The payment on account of Dearness Allowance involving a fraction of a rupee may be rounded off the nearest rupee.

This bears the approval of the competent authority.
