SUB :- GRANT OF DEARNESS ALLOWANCE TO THE BOARD EMPLOYEES REGULAR INCLUDING WORK CHARGED & GOVT. EMPLOYEES WHO ARE ON DEPUTATION.

The Board is pleased to order that the existing rates of Dearness Allowance (D.A.) payable to the Board Employees drawing pay in Rajasthan Civil Services (Revised Pay) Rules, 2008 under Finance Department Order No. F.6(1)FD(Rules)/2008 & F.14(14)FD/(Rules)/2006 Jaipur Dated 21-09-2013 Shall be revised with effect from 01-07-2013 as follow :-

| Date from which payable | Rate of Dearness Allowance payable per month |
|-------------------------|--|
| 01-07-2013 | 90% |

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. total of pay in running pay band and grade pay drawn and shall not include any other type (s) of like Special Pay of Personal Pay etc.

The payment of account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The arrears for the period from 01-07-2013 to 31-08-2013 shall be credited to the General Provident fund Account of the respective employees on or after and cash payment shall admissible from 01-09-2013 i.e. salary for the month of September 2013 in respect of Govt. Employees who are on deputation.

The arrear w.e.f. 01-07-2013 shall be paid in cash to the Board Employees (Regular including Work Charged)


The arrear of DA from 01-07-2013 to 31-08-2013 to the employees recruited to the civil Services on or after 01-01-2004 and who are governed by Contributory Pension scheme, shall be paid in cash.
