Criteria for assessment for respective work would be as follows:

- i. The bidder should have executed at least 33.00% of the following quantities of work in any one of the last five financial years inclusive of current year.
  - A. Plantation Work in Aravali Vihar & Sector 4 & 7 Residential Scheme, With Maintenance for 5 years at Bhiwadi

- ii. The bidder shall have completed maintenance work of similar nature, at least 5 years during the last 10 years.
- iii. The bidder should have completed at least one work of similar nature in last 5 years of the value not less than 50.00% of the estimated cost of the work updated to present price level.
- iv. The bidder should have achieved a financial turnover of at least 60% of the cost of the work (Bid cost) in any one of the last Five financial years.

- i. The bidder must be a company/firm/sole proprietor registered in India for the last five years as on the bid submission date.  
Joint venture or joint development partnership will be allowed. Joint development partners must not be more than two and minimum turnover of lead partner must be 50% of the turnover required for the project.
- ii. Bidder must have annual average turnover of Rs..... lakh (60% of the estimated cost of bid) of the last four financial year 2020-21, 2021-22, 2022-23 & 2023-24 (provision audited statement for 2023-24).
- iii. The bidder must have completed satisfactorily one order of providing horticulture services of at least 33.33% of the bid cost in last five years updated to present price level of government departments/ autonomous bodies/ PSUs/ reputed private organizations.
